IIIB Aging & Disability Resource Network (ADRN) Access Package

Service	Unit Definition	Service Activity Example	Units to Report/Where
Information & Assistance (I&A)	One Contact	Staff <u>assists client in person</u> at the office with a housing application. Staff later makes a <u>phone call to the</u> <u>housing complex</u> w/a question on client's behalf. Staff <u>calls client</u> to discuss status of application and learns client needs resources for food. <u>A list of food pantries is mailed to the client</u> .	4 units under I&A
Outreach	One Contact. Outreach units are based on one-on- one contacts by a service provider.	Staff <u>conducts outreach call</u> to an older adult not previously known to the agency and discusses services and resources available.	1 unit under Outreach
Options Counseling	One Contact. See additional guidance under "Other Helpful Information."	Client needs assistance obtaining permanent affordable housing and isn't sure where to start so Options Counseling is provided. <u>Staff have 10 contacts with</u> <u>client in 3 months related to initial goal of obtaining</u> <u>housing</u> , which included 3 phone calls with the soon-to-be-landlord.	10 units under Options Counseling
Flexible Community Services (FCS)	One person=One Unit FCS persons and units should always be the same number	Client needs assistance with rental assistance. Provider pays the overdue rental payment. Note: Client may also be receiving assistance for FCS via I&A or Options Counseling. Report units as indicated above.	1 unit under FCS

Other Helpful Information:

- Persons should be reported as unduplicated by service, by year. Example: If there are 5 I&A contacts with Fred Rogers in one fiscal year, he is reported as 1 person for the whole fiscal year who received 5 units of service.
- Units for I&A, Outreach and Options Counseling may be counted for active methods of contact with clients such as: phone calls or virtual assistance (e.g. Zoom), in-person assistance, chat messaging, active referrals or follow ups to another service provider made on behalf of a client, and outgoing mail or email to clients with information and resources. Incoming emails, faxes, letters, or requests received on your website/social media may not be counted as units. A unit of service cannot be counted until the provider actively provides information back to the client (or person contacting on their behalf).
- If a worker begins providing I&A and then turns the same interaction with a client into Options Counseling, then I&A CANNOT be counted in addition to Options Counseling, since Options Counseling is the primary service being provided. However, if the worker schedules a separate appointment with the client for Options Counseling, then the initial interaction can be counted as I&A.
- Once Options Counseling has begun with the client, follow up contacts with or on behalf of the client will be counted as
 Options Counseling units while the case is open and active. If the client contacts you after the Options Counseling case has
 been closed, then you would count the contact (unit) under the appropriate service (for example, I&A). However, if the
 issue/need is related to their previous Option Counseling case or it seems appropriate again to offer Options Counseling –
 then you can count those contacts as Options Counseling units.

Other Helpful Information: If Billie was a counseling client who attends the loss group therapy and has one-on-one therapy, she would be one person for the entire fiscal year, but each contact would be a unit.

Other Helpful Information: Persons should be reported as unduplicated by service, by year. Example: If there are 40 units of service provided to Mr. Singh in one fiscal year, he is reported as 1 person for the whole fiscal year who received 40 units of service. If Mr. Singh continues with the program into the next fiscal year, he again becomes a new unduplicated person, and the units of service count starts over again.

IIIB Friendly Visiting

Service	Unit Definition	Service Activity Example	Units to Report/Where
Friendly Visiting	One hour of staff/volunteer time expended on behalf of a participant constitutes one unit of service.	Ms. Johnson enrolls on April 5th. In April, the coordinator spends <u>3 hours</u> with Ms. Johnson to start services including matching her with Betty, a volunteer. In May, Betty spends <u>4 hours</u> visiting plus <u>2 hours</u> travel time. In June, Betty spends <u>6.5</u> <u>hours</u> visiting plus <u>2 hours</u> travel time.	17.5 units under Friendly Visiting (1 unduplicated person)

Other Helpful Information:

- Units of service based upon one hour of staff/volunteer time expended on behalf of a participant include the time necessary for preparation, travel, and case documentation.
 - 1. Examples of activities that can be included in your unit of service count: conducting interviews and completing intake. Forms with participants, participant/volunteer matching, administering Loneliness scales, documenting case notes, travel to/from a participant's home, making a referral to a local service agency on the participant's behalf, etc.
- Units of service do not include administrative activities such as preparation of reports and grant applications.
- Units should be measured to the nearest quarter hour.
- Persons should be reported as unduplicated by service, by year. Example: If there are 35 units of service expended on behalf of Ms. Johnson in one fiscal year, she is reported as 1 person for the whole fiscal year who received 35 units of service. If Ms. Johnson continues with the program into the next fiscal year, she again becomes a new unduplicated person and the units of service count starts over again.

Other Helpful Information:

- The service unit does not include any other activity, and a participant must be transported to or from a communitybased location.
- Persons should be reported as unduplicated by service, by year. Example: If there are 11 units of service provided to a participant in one fiscal year, they reported as 1 person for the whole fiscal year who received 11 units of service. If a participant continues with the program into the next fiscal year, they again become a new unduplicated person and the units of service count starts over again.
- If a family caregiver, grandchild, or adult child with developmental disabilities accompanies an older adult participant on a ride, only the older adult participant is counted as an unduplicated person for reporting purposes.

Other Helpful Information: One person can be counted once in each of these service areas without being considered a duplicate person. For instance, if Billie attends a recycling event under education and a craft meeting under recreation, she would be counted as one person under education and one person under recreation. However, if she attends weekly crafting classes, she would be counted as once person under recreation for the entire fiscal year, but then as a new person at the beginning of the next fiscal year.

IIIC Congregate and Home Delivered Meals

Service	Unit Definition	Service Activity Example	Units to Report/Where
Congregate Meal	One meal	 A hot or other appropriate meal served in a center strategically located to maximize access by older persons within a community. An older adult had a meal (breakfast, lunch, or dinner) at a restaurant or a senior center in the Congregate dining program. 	1 unit under Congregate meal
Congregate - Shelf stable meal	One meal	 A meal consisting of canned and dried foods not requiring refrigeration or freezing, ready to eat with minimal preparation (i.e., heating soup) and intended to be used during inclement weather or other emergencies making delivery of meals not feasible. An older adult received a 3-pack of shelf stable meals while participating in the Congregate dining program at the park district or other approved congregate dining sites. 	3 units under Congregate shelf stable meals
Home Delivered Meal (HDM)	One meal	A meal which is hot, cold, frozen, dried, or canned served to older persons who are home bound. An older adult received a delivery of 5 meals in one week; or an older adult received a delivery of 7 meals in one week (weekend meals)	5 units under type (hot, cold, or frozen); or 7 units under type (hot, cold, or frozen)
HDM Hot meal	One meal	A meal which is hot when delivered and eaten. An older adult received 1 (hot) home delivered meal and 4 (frozen) home delivered meals during a Monday delivery.	1 unit under HDM Hot and 4 units under HDM Frozen

Other Helpful Information:

Unduplicated persons are the number of different eligible persons who have consumed a meal during the current fiscal year (AgeGuide).

If there are 7 people attending a weekly education or counseling session, then the unit count would be 7, the unduplicated count of people served is 7. If during the second weekly educational or counseling session, 4 people return from the first meeting and 4 new people join, then the unit count for the month to date would be 15 (7 sessions in 1st week + 8 sessions in 2nd week), and the unduplicated count of people served is 11 (7 people in 1st week + 4 new people in 2nd week). (IDOA 603.20 D)

Nutrition Unit of Service: Each meal provided to an eligible person constitutes one unit of service (IDOA 603.20 D). Partial meals are not counted as a unit. Second meals can be counted as a unit for reporting and record- keeping purposes only if a complete meal is served (AgeGuide).

Nutrition service providers are eligible to receive Administration on Aging (AoA) cash assistance in the form of a funding allocation for meals served through AoA's NSIP Nutrition Program for the Elderly. Allocated funding may be claimed for meals that meet the dietary guidelines as specified by the Illinois Department on Aging and are served to eligible participants, which include persons 60 years of age or older, their spouses, disabled persons and volunteers as described in Section IV G 1 &2 above. **NSIP reimbursement may NOT be claimed for meals served to guests or staff under 60 years of age.**

Other Helpful Information: Persons should be reported as unduplicated by service, by fiscal year. If Jane Smith receives Access, Gap, and Counseling, she is reported once as a person in each service during the fiscal year. If Jane receives Access Services 10 times in one fiscal year, she is reported as 1 person for the whole fiscal year who received 10 units of service.
