

IL Grandparents Raising Grandchildren (IL GRG)

Eligibility: Grandparents and other non-parent relatives, of any age, caring for related children. AgeGuide focuses on grandparents under 55.

Supportive Gap: Financial assistance for grandparent and child needs such as clothing, food, shelter, etc.

Counseling Services: One on one mental health support for grandparents/relatives

Legal Services: Support for grandparents/relatives to obtain legal guardianship or other legal remedies

Respite: Short term relief of caregiving duties such as summer camp, music classes, etc.



Senior Community Service Employment Program (SCSEP)

Program Description: Federal Title V program designed to assist adults age 55 and older in entering or reentering the job market.

Program Administrator: Illinois Department on Aging

Eligibility: age 55 and older, income not more than 125% poverty level, capable of performing tasks for the assignment

Services: 20 hours/week at minimum wage, employment counseling, job training

Delivered By: National ABLE Network (Kankakee, Will, Grundy, DuPage, Kendall); National Asian Pacific Center on Aging (Lake, McHenry)

Program Description: Aging Waiver Program for home and community-based services under the Medicaid Program

Program Administrator: Illinois Department on Aging (IDOA) and Illinois Department of Healthcare and Family Services (HFS)

Eligibility: 60 years and older, US citizen or eligible non-citizen, resident of Illinois, non-exempt assets of \$17,500 or less, assessed need for long term care

Services: Care coordination, in-home services, emergency home response, adult day services, automated medication dispenser

Delivered By: Local Care Coordination Units and Managed Care Organizations

Managed Care Organizations (MCOs): Private insurance companies who contract with the Illinois Department of Healthcare and Family Services. Coordinate care for Community Care Program (CCP) Clients who are on Medicaid.

Intersection of OAA and CCP

Individuals who receive CCP and/or are part of an MCO **are eligible** to receive OAA services.

OAA services should be used in conjunction with CCP services to support older adults in their homes. CCP/MCO clients **are part of the OAA target population** as they are often living in poverty, living alone or minority/limited English speaking.

While many CCUs are also providers of OAA services, sometimes, OAA services, such as caregiver and nutrition services, are provided in agencies other than the CCUs.

OAA providers **should refer** clients to other services when a need is present such as CCP, other OAA services (provided outside of their organization), and Medicare/Benefits Access services.

Additional CCU Programs

Emergency Senior Services (ESS): Financial Assistance for CCP participants to fill gaps in services

IL Care Connections (ICC): offers access to assistive technology devices (AT) and durable medical equipment (DME) for CCP and non-CCP participants to assist them in living more independently and safely. Intended to help them to be more connected to family, friends, access health providers and participate in recreational activities through technology. IATP Website

Adult Protective Services (APS)

Program Description: Conduct investigations and work with adults age 60+ or people 18-59 with disabilities in resolving abuse, neglect, self-neglect or financial exploitation

Program Administrator: Illinois Department on Aging

Eligibility: people 60+ or 18-59 with disabilities, allegations meet criteria for ANE/Self Neglect, live in the community, in some cases alleged victims can live in facilities.

Delivered By: Designated community-based Adult Protective Services Provider Agency (APSPA)

Adult Protective Services (APS)

Limited Mandated Reporting

Adult Protective Services Act 320 ILCS 20

Summary: (a-5) If any mandated reporter has reason to believe that an eligible adult, who because of a disability or other condition or impairment is unable to seek assistance for himself or herself, has, within the previous 12 months, been subjected to abuse, abandonment, neglect, or financial exploitation, the mandated reporter shall, within 24 hours after developing such belief, report this suspicion to an agency designated to receive such reports under this Act or to the Department.

Program Description

Veterans Directed Care program, providing home and communitybased services chosen by the veteran and/or caregiver

Eligibility

VA determines eligibility and makes referrals; must demonstrate need, at risk of institutional placement; Services are based on VA rather than a geographic location
