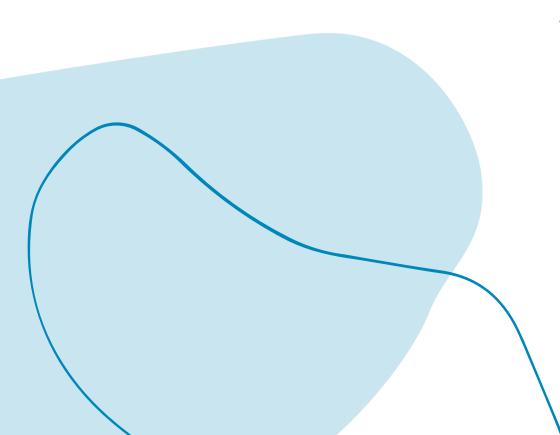

What is the Difference **Between State** & Federal Funds?

- State Funds follow the State Fiscal Year: July 1st – June 30th
- Federal Funds follow the Federal Fiscal Year: October 1st – September 30th
- Other smaller grants can also have different fiscal periods, for example, SHIP grants

Cash Requests

Cash requests are not needed for most grants. Grants are distributed monthly.

Special Grants require monthly Cash Requests

Updated cash requests are emailed by the end of each month

Cash Requests are due to Fiscal (fiscal@ageguide.org) by the **7th of the month**

All requests are due to IDoA on the **10th** of the month

Timeline of Money

Cash Request due to AgeGuide

7th of every month (Submitted May for April) Cash Request due to IDOA

10th of every month (Submitted May for April) Money Received

AgeGuide Receives the money roughly 30-45 days following submission of Cash Request (End of June) Money Sent out to Grantees

Roughly within a week of receiving the money
AgeGuide will turn it around to the Grantees
