### AgeGuide Teams - Responsibility to Our Grantees

#### **Grants Team**

- Collect and review quarterly progress reports (fiscal and program)
- Review budgets, applications, and issue NGAs and other agreements
- Review grantee progress throughout the year, including match, amount disbursed
- Conduct grantee fiscal monitoring

#### **Fiscal Team**

- Receive and review monthly cash requests
- Disburse funds to grantees
- Answer grantee questions about disbursements and availability of funds
- Report disbursements to Grants Team for grantee monitoring purposes

#### **Program Team**

- Review quarterly units and persons performance
- Provide program guidance and support
- Conduct grantee program monitoring

\*For all programs except Nutrition – program responsibilities for C1/C2 are managed by Grants Team


